Landfill concerns haven't been addressed

Oncerned citizens recently launched a campaign to 'Close the Richmond Landfill.' In response, Waste Management made statements to the press that I feel require a response.

Contrary to Waste Management claims, Ministry of the Environment scientists do have concerns with this site. Earlier this year, a Ministry report stated that "significant contaminant migration could occur" and that the hydrogeological model proposed by Waste Management is "unacceptable." MOE memos from 2007 express concerns with the groundwater monitoring program and cite a risk of surface water contamination. Ministry reports and recent statements from MOE staff reveal that they do not understand the groundwater flow beneath the Richmond Landfill. In 2006, a Ministry Review concluded that "the landfill is a potential source of groundwater contamination in a susceptible subsurface environment." This does not sound like a ministry with no concerns.

Waste Management also stated that there is no evidence that offsite contamination is occurring. Once again, experts would disagree. This year, the residents' hydrogeologist cited "strong evidence that surface water contamination is occurring" and he estimates that "50 per cent of the landfill's waste footprint is leaking into the groundwater flow system." Ministry staff themselves have noted strong odors near the site. In 2006, Queen's Toxicologist Dr. Forkert stated that "odors may act as markers for toxicologically significant exposures" of harmful chemicals in landfill gas. Also in 2006, a MOE hydrogeologist expressed concern about the "quantity and environmental fate of leachate entering the subsurface through the site's operational history." Most recently, scientific consultants found elevated levels of leachate indicators in offsite groundwater samples.

Given that the Ministry of the Environment itself has identified the clear risks posed by this landfill, their inaction is of serious concern. It's time for the ministry to fulfill its responsibility to the people of this province by closing the dump now.
